Toshiba Global Commerce Solutions (TGCS) Statement of Limited Warranty

Part 1 - General Terms

This Statement of Limited Warranty includes Part 1 - General Terms, Part 2 - Country-unique Terms, Part 3 - Warranty Information, and Part 4 – Product Warranty Table. The terms of Part 2 replace or modify those of Part 1. Part 3 and Part 4 (collectively also called, "Warranty Information") includes Product-specific information which ships with the Machine. For purposes of this Statement of Limited Warranty, "TGCS" means the TGCS entity that provided your Machine to you or to your reseller—for example, Toshiba Global Commerce Solutions, Inc. in the U.S. or the local Toshiba Global Commerce Solutions (TGCS) entity responsible for distributing product in your country.

The warranties provided by TGCS in this Statement of Limited Warranty apply only to Machines you purchase for your use, and not for resale. This warranty applies to a Machine in the countries specified for such Machine in the Warranty Information. Your point of purchase may provide additional or different warranties or services; TGCS is not responsible for any such additional or different warranties or services provided by your point of purchase. If you have any questions concerning this limited warranty, please refer to your point of purchase. The term "Machine" means a TGCS machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. The term "Machine" does not include any software programs, whether pre-loaded with the Machine, installed subsequently, or otherwise. These terms will be effective for any product shipped on or after October 1, 2016.

NOTHING IN THIS STATEMENT OF LIMITED WARRANTY AFFECTS ANY STATUTORY RIGHTS OF CONSUMERS THAT CANNOT BE WAIVED OR LIMITED BY CONTRACT.

What this Warranty Covers

TGCS warrants that each Machine is free from defects in materials and workmanship and conforms to its specifications. "Specifications" is information specific to a Machine in a document entitled "Official Published Specifications", which is available upon request.

During the warranty period, TGCS or a local service provider approved by TGCS ("Approved TGCS Service Provider") provides repair and exchange service for the Machine under the type of warranty service TGCS designates for the Machine (this warranty service may vary by country). The warranty period for the Machine is a fixed period of time unless specified otherwise in the "Warranty Information" that ships with the Machine (for example, for certain Machines, the warranty will void if the Machine's usage limitations are exceeded during the specified warranty period). The warranty period, type of warranty service, and service level that apply to your Machine are designated in the "Warranty Information" that ships with the Machine. TGCS may require you to provide proof of purchase (for example, a copy of your sales receipt or purchase invoice) to validate warranty entitlement.

If a Machine that TGCS is responsible to install is not made available for TGCS to install within six months from the date TGCS ships the Machine to you or the reseller, installation will be subject to a charge under a Services agreement with TGCS.

For a Machine that TGCS is responsible to install, if you elect to install or service the Machine yourself, or if you relocate the Machine or have a third party install, service or relocate the Machine, TGCS reserves the right to inspect the Machine before providing warranty Service on the Machine. TGCS may, at its sole discretion charge for the inspection. If the Machine is not in an acceptable condition for warranty Service, as solely determined by TGCS, you may request that TGCS restore it to an acceptable condition for Service or you may withdraw your request for warranty Service. TGCS, at its sole discretion, will determine if restoration is possible. Restoration is provided as a billable Service. If specified, additional charges, such as transportation or special handling, may apply.

Many features, conversions, or upgrades involve the removal of parts and their return to TGCS. A TGCS part or feature installed during the initial installation of a TGCS Machine is subject to the Machine's

warranty period effective on the Date of Installation (also called, "Warranty Start Date") of the Machine. A TGCS part or feature which replaces a previously installed part or feature assumes the remainder of the warranty period for the replaced part or feature. A TGCS part or feature added to a Machine without replacing a previously installed part or feature is subject to the specified warranty period for the applicable part or feature effective on its Date of Installation (also called, "Warranty Start Date). Unless TGCS specifies otherwise, the warranty period, type of warranty service, and service level of such part or feature is the same as the Machine on which it is installed.

Unless TGCS specifies otherwise, these warranties apply only in the country or region in which you purchased the Machine.

THESE WARRANTIES ARE YOUR EXCLUSIVE WARRANTIES AND REPLACE ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, AND ANY WARRANTY OF TITLE OR NON-INFRINGMENT. SOME STATES OR JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF EXPRESS OR IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU. IN THAT EVENT, SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD. SOME STATES OR JURISDICTIONS DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

What this Warranty Does Not Cover

This warranty does not cover the following:

- A failure or damage resulting from misuse (including, but not limited to, use of any Machine capacity or capability, other than that authorized by TGCS in writing), accident, modification, unsuitable physical or operating environment, operation in other than the specified operating environment or improper maintenance by you or a third party;
- b. failure due to events beyond TGCS' control;
- c. failure caused by a product for which TGCS is not responsible;
- d. any non-TGCS products, including those provided with, or installed on, a TGCS Machine at your request;
- e. accessories, supply items and consumables, and structural parts (for example, frames and covers).
 - Unless specified otherwise, batteries are considered a consumable item and are not warrantied. If warranted, TGCS will specify the warranty in the Product announcement and service documentation which ships with the Machine;
 - Thermal Print Head Life and Auto Cutter Life are guaranteed only with the use of papers on the TGCS qualified paper list. Use of non-qualified paper sources may result in a shorter lifespan and may result in a billable service call if printer failures are determined by TGCS to be the result of using these papers, regardless of the existence of a service contract or product warranty.
- f. service of Machine alterations; and
- g. service of a Machine on which you are using capacity or capability, other than that authorized by TGCS in writing.
- h. certification in your country for the Machine's connection by any means to interfaces of public telecommunications networks unless TGCS specifies otherwise in the Product announcement and service documentation that ships with the Machine. Further certification may be required by law prior to making any such connection.
- i. All Operating programs, software, microcode, device driver and firmware.

The warranty is voided by removal or alteration of identification labels on the Machine or its parts.

TGCS does not warrant uninterrupted or error-free operation of a Machine.

Any technical or other support provided for a Machine under warranty, such as assistance with "how-to" questions and those regarding Machine set-up and installation, is provided **WITHOUT WARRANTIES OF ANY KIND**.

How to Obtain Warranty Service

If you purchased a Machine in a country where Toshiba Global Commerce Solutions (TGCS) does not sell or service customers directly, please contact the company from which you purchased the machine for any warranty service specified in the Warranty Information.

If the Machine does not function as warranted during the warranty period, refer to the service documentation that shipped with your Machine for support assistance and problem determination procedures. A copy of the service documentation for your Machine can also be found at the following TGCS website: www.toshibacommerce.com by selecting "Support Overview", and then "Publications".

If you are unable to resolve your problem with the service documentation, contact TGCS or the reseller to obtain warranty service. Contact information for TGCS is provided in the "Warranty Information" that ships with your Machine. If you do not register the Machine with TGCS, you may be required to present proof of purchase as evidence of your entitlement to warranty service.

What TGCS Will Do to Correct Problems

TGCS or an Approved TGCS Warranty Provider will attempt to diagnose and resolve your problem over the telephone or electronically by access to a TGCS website. Certain Machines contain remote support capabilities for direct problem reporting, remote problem determination, and resolution with TGCS. When you contact TGCS for service, you must follow the problem determination and resolution procedures that TGCS specifies. Following problem determination, if TGCS determines on-site service is required, a service technician will be scheduled for service at your location if the product is entitled to on-site service.

Unless specified otherwise, you are responsible for downloading (or obtaining from TGCS) and installing designated Machine Code (microcode, basic input/output system code (called "BIOS"), utility programs, device drivers, and diagnostics delivered with a TGCS Machine) and other software updates in a timely manner from a TGCS website or from other electronic media, and following the instructions that TGCS provides. You may request TGCS to install Machine Code changes, however, you may be charged for that service.

Some parts of TGCS Machines are designated as Customer Replaceable Units ("CRUs"). If your problem can be resolved with a CRU (e.g. keyboard, memory, hard disk drive) TGCS will ship the CRU to you for you to install.

If the Machine does not function as warranted during the warranty period and your problem cannot be resolved over the telephone or electronically, through your application of Machine Code or software updates, or with a CRU, TGCS or its subcontractor or a reseller that has been approved by TGCS to provide warranty service, will either, at its discretion, 1) repair it to make it function as warranted, or 2) replace it with one that is at least functionally equivalent. If TGCS or its subcontractor or the reseller is unable to do either, you may return the Machine to your place of purchase and your money will be refunded.

TGCS or its subcontractor or the reseller will also manage and install selected engineering changes that apply to the Machine.

Exchange of a Machine or Part

When the warranty service involves the exchange of a Machine or part, the item TGCS or its subcontractor or the reseller replaces becomes TGCS' property, and the replacement becomes yours. You represent that all removed items are genuine and unaltered. The replacement may not be new, but will be in good working order and at least functionally equivalent to the item replaced. The replacement assumes the warranty service status of the replaced item.

Your Additional Responsibilities

You agree:

- a. before TGCS or its subcontractor or the reseller exchanges a Machine or part, to remove all features, parts, options, alterations, and attachments not under warranty service and ensure that the Machine is free of any legal obligations or restrictions that prevent its exchange;
- b. to obtain authorization from the owner to have TGCS or its subcontractor or the reseller service a Machine that you do not own;
- c. where applicable, before service is provided:
 - (1) follow the service request procedures that TGCS or its subcontractor or its reseller provides;
 - (2) back-up and secure all programs, data, and funds contained in the Machine; and (3) inform TGCS or its subcontractor or the reseller of changes in the Machine's location;
- d. to provide TGCS or its subcontractor or the reseller with sufficient and safe access to your facilities to permit TGCS to fulfill its obligations;
- e. to allow TGCS or its subcontractor or the reseller to install mandatory engineering changes, such as those required for safety:
- f. when the type of warranty service requires that you deliver a failing Machine to TGCS, you agree to ship it suitably packaged, as TGCS specifies, to a location TGCS designates. After the Machine has been repaired or exchanged, TGCS will return the repaired Machine or provide a replacement Machine to you at its expense, unless TGCS specifies otherwise. TGCS is responsible for loss of, or damage to, your Machine only while it is 1) in TGCS' possession; or 2) in transit in those cases where TGCS is responsible for the transportation charges;
- g. to securely erase from any Machine you return to TGCS for any reason all programs not provided by TGCS with the Machine, and data, including without limitation the following: 1) information about identified or identifiable individuals or legal entities ("Personal Data"); and 2) your confidential or proprietary information and other data. If removing or deleting Personal Data is not possible, you agree to transform such information (e.g., by making it anonymous or encrypting it) so that it no longer qualifies as Personal Data under applicable law. You also agree to remove all funds from Machines returned to TGCS. TGCS is not responsible for any funds, programs not provided by TGCS with the Machine, or data contained in a Machine that you return to TGCS. You acknowledge that, to perform its responsibilities under this Statement of Limited Warranty, TGCS may ship all or part of the Machine or its software to other TGCS or third party locations around the world, and you authorize TGCS to do so.

Limitation of Liability

Circumstances may arise where, because of a default on TGCS's part or other liability, you are entitled to recover damages from TGCS. Regardless of the basis on which you are entitled to claim damages from TGCS (including fundamental breach, negligence, misrepresentation, or other contract or tort claim), except for any liability that cannot be waived or limited by applicable laws, TGCS's entire liability for all claims in the aggregate arising from or related to each Product will not exceed:

- a. damages for bodily injury (including death) and damage to real property and tangible personal property; and
- b. the amount of any other actual direct damages, up to the charges (if recurring, 12 months' charges apply) for the Machine that is subject of the claim. For purposes of this item, the term "Machine" includes Machine Code and Licensed Internal Code ("LIC").

This limit also applies to TGCS suppliers, subcontractors, and resellers. It is the maximum for which TGCS and its suppliers, subcontractors, and resellers are collectively responsible.

UNDER NO CIRCUMSTANCES IS TGCS OR ITS SUPPLIERS, SUBCONTRACTORS, OR RESELLERS LIABLE FOR ANY OF THE FOLLOWING EVEN IF INFORMED OF THEIR POSSIBILITY:

- 1) THIRD PARTY CLAIMS AGAINST YOU FOR DAMAGES (OTHER THAN THOSE UNDER THE FIRST ITEM LISTED ABOVE);
- 2) LOSS OF, OR DAMAGE TO, DATA;
- 3) SPECIAL, INCIDENTAL, OR INDIRECT DAMAGES OR FOR ANY ECONOMIC CONSEQUENTIAL DAMAGES; OR
- 4) LOST PROFITS, BUSINESS, REVENUE, GOODWILL OR ANTICIPATED SAVINGS. SOME STATES OR JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU.

Governing Law

Both you and TGCS consent to the application of the laws of the country in which you acquired the Machine to govern, interpret, and enforce all of your and TGCS's rights, duties, and obligations arising from, or relating in any manner to, the subject matter of this Statement of Limited Warranty, without regard to conflict of law principles.

THESE WARRANTIES GIVE YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE OR JURISDICTION TO JURISDICTION.

Jurisdiction

All of our rights, duties, and obligations are subject to the courts of the country in which you acquired the Machine.

Part 2 - Country-unique Terms

AMERICAS

Jurisdiction:

The following sentence is added to this section as it applies to countries in bold print below:

Any litigation arising from this Statement of Limited Warranty will be settled exclusively by 1) in **Argentina**; the Ordinary Commercial Court of the city of Buenos Aires; 2) in **Bolivia**; the courts of the city of La Paz; 3) in **Brazil**; court of Rio de Janeiro, RJ; 4) in **Chile**; the Civil Courts of Justice of Santiago; 5) in **Colombia**; the Judges of the Republic of Colombia; 6) in **Ecuador**; the civil judges of Quito for executory or summary proceedings (as applicable); 7) in **Mexico**; the courts located in Mexico City, Federal District; 8) in **Paraguay**; the courts of the city of Asuncion; 9) in **Peru**; the judges and tribunals of the judicial district of Lima, Cercado; 10) in **Uruguay**; the courts of the city of Montevideo; 11) in **Venezuela**; the courts of the metropolitan area of the city of Caracas.

BRAZIL

Exchange of a Machine or Part:

The replacement assumes the warranty service status of the replaced item.

CANADA

What this Warranty Covers:

The following replaces the 2nd paragraph to this section:

During the warranty period, TGCS provides repair and exchange service for the Machine under the type of warranty service TGCS designates for the Machine. The warranty period for the Machine is a fixed period of time starting on its original Date of Installation (also called, "Warranty Start Date") unless specified otherwise in the "Warranty Information" that ships with the Machine (for example, for certain Machines, the warranty will void if the Machine's usage limitations are exceeded during the specified warranty period). The warranty period, type of warranty service, and service level that apply to your Machine are designated in the "Warranty Information" that ships with the Machine. TGCS may require you to provide proof of purchase (for example, a copy of your sales receipt or purchase invoice) to validate warranty entitlement.

Limitation of Liability:

The following replaces items a and b of this section:

- a. damages for bodily injury (including death) or physical harm to real property and tangible personal property caused by TGCS's negligence; and
- b. the amount of any other actual direct damages, up to the greater of \$100,000.00 or the charges (if recurring, 12 months' charges apply) for the Machine that is subject of the claim. For purposes of this item, the term "Machine" includes Machine Code and Licensed Internal Code ("LIC").

Governing Law:

The following replaces "laws of the country in which you acquired the Machine" in the first sentence: laws in the Province of Ontario.

PERU

Limitation of Liability:

The following is added at the end of this section:

In accordance with Article 1328 of the Peruvian Civil Code the limitations and exclusions specified in this section will not apply to damages caused by TGCS's willful misconduct ("dolo") or gross negligence ("culpa inexcusable").

UNITED STATES

Governing Law:

The following replaces "laws of the country in which you acquired the Machine" in the first sentence: laws of the State of New York

ASIA PACIFIC

AUSTRALIA

What this Warranty Covers:

The following paragraphs are added to this section:

The warranties specified in this Section are in addition to any rights you may have under the Australian Consumer Law or other similar legislation and are only limited to the extent permitted by the applicable legislation. Throughout this document "Australian Consumer Law" means Schedule 2 of the Competition and Consumer Act 2010. Where a product we supply to you is, for the purposes of the Competition and Consumer Act 2010 deemed to be a "consumer transaction" (as defined in the Australian Consumer Law) then, in addition to your other rights under our agreement, the following may apply:

Our goods come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure and for compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure.

Limitation of Liability:

The following is added to this section:

To the extent permitted by law, where TGCS is in breach of a guarantee under the Australian Consumer Law or other similar legislation, TGCS's liability is limited, at its option to:

- a. for services:
 - (1) the supply of the services again or
 - (2) the payment of the cost of having the services supplied again; and
- b. for goods:
 - (1) the repair or replacement of the goods or the supply of equivalent goods; or
 - (2) the payment of the cost of having the services supplied again.

Where that guarantee relates to the right to sell, quiet possession or clear title, or if the goods are of a kind ordinarily acquired for personal, domestic or household use or consumption, then none of the limitations in this paragraph apply.

Governing Law:

The arbitration award shall be final and binding for the parties without appeal and shall be in writing and set forth the findings of fact and the conclusions of law.

The number of arbitrators shall be three, with each side to the dispute being entitled to appoint one arbitrator. The two arbitrators appointed by the parties shall appoint a third arbitrator who shall act as chairman of the proceedings. Vacancies in the post of chairman shall be filled by the president of the

SIAC. Other vacancies shall be filled by the respective nominating party. Proceedings shall continue from the stage they were at when the vacancy occurred.

If one of the parties refuses or otherwise fails to appoint an arbitrator within 30 days of the date the other party appoints its, the first appointed arbitrator shall be the sole arbitrator, provided that the arbitrator was validly and properly appointed.

All proceedings shall be conducted, including all documents presented in such proceedings, in the English language. The English language version of this Statement of Limited Warranty prevails over any other language version.

HONG KONG S.A.R.

As applies to transactions initiated and performed in Hong Kong S.A.R., phrases throughout this Agreement containing the word "country" (for example, "country of purchase" and "country of Installation") are replaced with "Hong Kong S.A.R.."

INDIA

Limitation of Liability:

The following replaces items a and b of this section:

a. liability for bodily injury (including death) or damage to real property and tangible personal property will be limited to that caused by TGCS's negligence; and

b. as to any other actual damage arising in any situation involving non-performance by TGCS pursuant to, or in any way related to the subject of this Statement of Limited Warranty, the charge paid by you for the individual Machine that is the subject of the claim. For purposes of this item, the term "Machine" includes Machine Code and Licensed Internal Code ("LIC").

Arbitration:

The following is added under this heading:

Disputes arising out of or in connection with this Statement of Limited Warranty shall be finally settled by arbitration which shall be held in Bangalore, India in accordance with the laws of India then in effect. The arbitration award shall be final and binding for the parties without appeal and shall be in writing and set forth the findings of fact and the conclusions of law.

The number of arbitrators shall be three, with each side to the dispute being entitled to appoint one arbitrator. The two arbitrators appointed by the parties shall appoint a third arbitrator who shall act as chairman of the proceedings. Vacancies in the post of chairman shall be filled by the president of the Bar Council of India. Other vacancies shall be filled by the respective nominating party. Proceedings shall continue from the stage they were at when the vacancy occurred.

If one of the parties refuses or otherwise fails to appoint an arbitrator within 30 days of the date the other party appoints its, the first appointed arbitrator shall be the sole arbitrator, provided that the arbitrator was validly and properly appointed.

All proceedings shall be conducted, including all documents presented in such proceedings, in the English language. The English language version of this Statement of Limited Warranty prevails over any other language version.

JAPAN

Governing Law:

The following sentence is added to this section:

Any doubts concerning this Statement of Limited Warranty will be initially resolved between us in good faith and in accordance with the principle of mutual trust.

MACAU S.A.R.

As applies to transactions initiated and performed in Macau S.A.R., phrases throughout this Agreement containing the word "country" (for example, "country of purchase" and "country of Installation") are replaced with "Macau S.A.R."

MALAYSIA

Limitation of Liability:

The word "SPECIAL" in item 3 of the last paragraph is deleted.

NEW ZEALAND

What this Warranty Covers:

The following paragraph is added to this section:

The warranties specified in this section are in addition to any rights you may have under the Consumer Guarantees Act 1993 or other legislation which cannot be excluded or limited. The Consumer Guarantees Act 1993 will not apply in respect of any goods which TGCS provides, if you require the goods for the purposes of a business as defined in that Act.

Limitation of Liability:

The following is added to this section:

Where Machines are not acquired for the purposes of a business as defined in the Consumer Guarantees Act 1993, the limitations in this Section are subject to the limitations in that Act.

PEOPLE'S REPUBLIC OF CHINA (PRC)

Governing Law:

The following replaces "laws of the country in which you acquired the Machine" in the first sentence: laws of the State of New York, United States of America (except when local law requires otherwise).

PHILIPPINES

Limitation of Liability:

Item 3 in the last paragraph is replaced by the following:

SPECIAL (INCLUDING NOMINAL AND EXEMPLARY DAMAGES), MORAL, INCIDENTAL, OR INDIRECT DAMAGES FOR ANY ECONOMIC CONSEQUENTIAL DAMAGES; OR Arbitration:

The following is added: under this heading

Disputes arising out of or in connection with this Statement of Limited Warranty shall be finally settled by arbitration which shall be held in Metro Manila, Philippines in accordance with the laws of the Philippines then in effect. The arbitration award shall be final and binding for the parties without appeal and shall be in writing and set forth the findings of fact and the conclusions of law.

The number of arbitrators shall be three, with each side to the dispute being entitled to appoint one arbitrator. The two arbitrators appointed by the parties shall appoint a third arbitrator who shall act as chairman of the proceedings. Vacancies in the post of chairman shall be filled by the president of the Philippine Dispute Resolution Center, Inc. Other vacancies shall be filled by the respective nominating party. Proceedings shall continue from the stage they were at when the vacancy occurred.

If one of the parties refuses or otherwise fails to appoint an arbitrator within 30 days of the date the other party appoints its, the first appointed arbitrator shall be the sole arbitrator, provided that the arbitrator was validly and properly appointed.

All proceedings shall be conducted, including all documents presented in such proceedings, in the English language. The English language version of this Statement of Limited Warranty prevails over any other language version.

SINGAPORE

Limitation of Liability:

The words "SPECIAL" and "ECONOMIC" in item 3 in the last paragraph are deleted. EUROPE, MIDDLE EAST, AFRICA (EMEA)

THE FOLLOWING TERMS APPLY TO ALL EMEA COUNTRIES:

The terms of this Statement of Limited Warranty apply to Machines purchased from TGCS or a TGCS reseller.

How to Obtain Warranty Service:

Arbitration:

The following is added under this heading:

Types of Warranty Service

Type 1 - Customer Replaceable Unit ("CRU") Service

TGCS provides replacement CRUs to you for you to install. CRU information and replacement instructions are shipped with your Machine and are available from TGCS at any time on your request. CRUs are designated as being either a Tier 1 (mandatory) or a Tier 2 (optional) CRU. Installation of a Tier 1 CRU is your responsibility. If TGCS installs a Tier 1 CRU at your request, you will be charged for the installation. You may install a Tier 2 CRU yourself or request TGCS to install it, at no additional charge, under the type of warranty service designated for your Machine. TGCS specifies in the materials shipped with a replacement CRU whether a defective CRU must be returned to TGCS. The Service Center will, at its discretion, repair or replace the motherboard, barebones, small board, power supply or other such part. The cables and mechanical parts, including chassis, rail, heat sink, I/O shield, etc. of the product are excluded from the coverage of this warranty.

The product will be shipped to the Service Center for replacement or repair. You shall pay for the one-way shipping charges from your location to the Service Center. If no defect is found on the returned product, if it has defaulted due to (a) physical damage by the user, (b) use of external components not

included in the original product, (c) misuse by the user, (d) unsuitable power sources or environmental conditions, (e) normal wear and tear, or (f) damaged during shipping en route to the Service Center, you are fully responsible for all fees incurred for returning the product to your location. The Service Center will not be responsible for any losses or damage to the product incurred while the product is in transit or is being shipped for repair. Insurance is recommended.

The Service Center will return the repaired product around 14 working days after the products have been received at the Service Center. If parts such as the CPU, DIMM, HDD, Power supply need to be replaced, the product will be returned around 30 working days after it has been received.

Service Levels

Service levels specified below are response-time objectives only and are not guarantees. The specified service level may not be available in all worldwide locations. Charges may apply outside TGCS's normal service area.

Next Business Day Warranty Service (NBD) is based on commercially reasonable efforts to respond to service request not later than close of business the day following the service request.

Parts Only is available in selected countries. Under the Parts Only warranty, TGCS will furnish replacement parts under the normal parts replenishment process. It is your responsibility to arrange for service for replacement of the part through your local service provider. Parts return policy may vary by country.

Out of Box Warranty is available on selected Machines in select countries. Under the out of box warranty, the specified service level term will be through the first successful power up and boot of the Machine.

Same Day Warranty Service (SDS) is based on commercially reasonable efforts to respond to service request the same day. This service level is available 365 days a year. Travel limitations may apply.

TGCS encourages you to use available remote support technologies. Failure to install and use available remote connectivity tools and equipment for direct problem reporting, remote problem determination and resolution may result in an increased service level response-time due to resource requirements.

Service Upgrades may be available for products to enhance the service level of the warranty or to extend the length of the warranty period. Please contact TGCS or an Approved TGCS Service Provider for more details.

Selectable Service options are upgrades to service that replace base warranty.
